



'Intersecting Violences: A Review of Feminist Theories and Debates on Violence against Women and Poverty in Latin America.'



This research report aims to provide a greater understanding of why women are abused and discriminated against in Latin America: the structural causes of their subjugated status, the relationship between cultural, sexual, racial and economic structures, and the pervasiveness of both VAW and women's poverty.

Speakers: Yakin Ertürk, former UN Special Rapportuer on VAW & **Patricia Muñoz Cabrera**, author of the research and chair of Women in Development Europe (WIDE).

- **Ssuccessful launch in Honduras**



On the 30th July, the Spanish version of our research was launched in Tegucigalpa, Honduras. Speakers Patricia Muñoz Cabrera and Katherine Ronderos addressed an audience of over 50 people including

academics, practitioners and policy makers, all of whom welcomed the report and its potential for future work on violence against women and poverty in Latin America.

2. CAWN news

- **Field visit to Honduras**

CAWN staff member, Katherine Ronderos, spent two weeks in Honduras in July, monitoring the project on violence against women (VAW) with

our partner organisation CEMH. Katherine found that the women's groups supported by the project have successfully continued their work over the last year, empowering women to speak out against domestic violence and providing income generation workshops and public awareness activities.



However, Katherine also brought back news that although matters seem more stable over a year after the coup, there remains a strong undercurrent of violence and fear, with leaders of the resistance still being threatened, disappeared and murdered, albeit more discreetly.

• **Successful capacity building seminar held with CAWN & LAWRS**

On Saturday 18th September, 20 members of CAWN and LAWRS (the Latin American Women's Rights Service) met to discuss how best to identify and respond to the practical and strategic needs of Latin American women, both in the UK and in Latin America. The day was considered a success by both organisations and was a fantastic opportunity to exchange knowledge and experiences.

3. CAWN campaigns

• **Violence Against Women update**

As the fourth year of the project on VAW in Honduras drew to a close in July, CAWN and CEMH took the opportunity to reflect on the successes of the project thus far and the areas to focus on in our final year. Our achievements include:

- over 100 women received training to be facilitators for 'self-help groups'

- over 500 women have received information and support from these self-help groups.
- over 280 female survivors of violence have received legal advice and support to initiate and continue legal proceedings
- over 200 men have received training enabling them to work with other men to champion non-violent masculinities

Our aims for the final year of our project include:

- increasing income generation workshops
- continuing work with indigenous women
- providing training on food sovereignty

- **'Intersecting Violences. A review of feminist theories and debates on violence against women and poverty in Latin America'**. (To be released on 21st October 2010*)

In commissioning this research, CAWN recognises the importance of bringing new approaches to work challenging VAW, while at the same time utilising existing expertise acquired through research on intersectionality both within the Central American region and in Europe.

The report considers the benefits of taking an intersectional approach to the complex and interrelated web of factors contributing to poverty

and VAW in Latin America, taking into account the multiple oppressing structures of economic neo-liberalism and political and patriarchal power, and the effects of these on women who have 'multiple subordinated identities'.

5. Central America updates

British Embassy in Guatemala to launch shock-campaign against domestic violence

The campaign 'Rompe el Ciclo' (Break the Cycle) will be launched at the Mexican Embassy in Guatemala on the 30th September. The UK Embassy will be working alongside the Guatemalan Presidency, civil society and the private sector to highlight the fact that children who grow up in violent homes come to see violence as normal and are thus more likely to become violent themselves. The campaign aims to shock but also to inspire individuals to move society and change attitudes towards domestic violence.

• 211 women murdered in Ciudad Juarez in 2010 thus far are 'not femicides'

Despite the high numbers of murders of women in Ciudad Juarez this year, 31 of which took place in the first half of September alone, Patricia González Rodríguez, the Attorney General for State Justice, claims that this does not signify an increase in femicides but rather indicates the increasing problems with drugs related gangs in the area. Indeed, out of the 211 murders of women, only 11 have been classed as femicide and thus investigated by the Fiscal Office of Homicides against Women. This shocking number of deaths in the last 9 months is almost half the number of murders of women that took place in the same area during the 10 years between 1993 and 2003.

• Statement released from the International Indigenous Women's Forum on the MDG's

This statement, entitled 'No More Promises - A Call to Action' calls on leaders to take specific steps during the MDG Review Summit in September to address the vast inequalities and social exclusion faced by indigenous peoples and women in particular. It urges the inclusion in the Summit outcome document of a number of paragraphs recognising the additional gender based disadvantages and discrimination faced by indigenous women and the importance of promoting full participation of indigenous peoples and particularly women in MDG related policies and programmes.

• Landmark adoption ruling for same sex couples in Mexico

Only one week after a decision in favour of the right to same sex marriage, Mexico's Supreme Court voted to guarantee adoption for same-sex couples. • No Olvidamos ni Aceptamos: Femicidio en Centroamerica 2000-2006. (We Don't Forget or Accept: Femicide in Central America 2000 - 2006) CEFEMINA, 2010

This investigation aims to discover whether the recent exponential increase in murders of women in Central America is part of a more generalised rise in violence, or more specifically an increase in femicides. In undertaking detailed field research on femicides in Central America it attempts to understand the role of additional factors such as class, poverty, social and economic exclusion, finding that homicides of women in this time have increased at a significantly greater rate than homicides of men and calling for State action to stop impunity, effectively protect women and put an end to toleration of violence against women and femicide.
