### • CAWN Research 2009 'Feminist Debates to address Violence against Women and Poverty'

CAWN has now recruited a Research Consultant for our latest Research project to be published in **November 2009**. Our partner organisation CEM-H (Centro de Estudios de la Mujer –Honduras), requested support from CAWN to prepare a report that presents an analysis of the main theoretical discussions and feminist debates about patriarchy, gender relations and violence and the links to poverty within the current economic system. A theoretical framework will also be useful for CAWN to assist us in our analysis of the issue of violence in Central America and to link the debates to our practical findings on the ground through the CEM-H project results. The report will be published in English and translated into Spanish for women in Central America, and will be an advocacy tool in the UK and internationally.

### • Indigenous Latin Americans mobilise to defend their rights

More than 2,000 Latin American indigenous people met to discuss and debate their proposals to defend their right to land on 27-31 May in Puno, Peru for a series of three summits, including the Fourth Continental Indigenous Peoples Summit, the First Indigenous Women Summit, and the Second Meeting of Childhood and Youth. Delegations of natives from Argentina, Bolivia, Brazil, Chile, Colombia, Ecuador, Guatemala, Mexico among other countries participated. For full article see:

### • Let's stop women's suffering

Human Rights organisations around the world are starting to demand that governments recognise preventable maternal death as a violation of women's rights. More than one woman dies every minute from preventable causes in childbirth, and for every woman who dies as many as 30 others are left with lifelong, debilitating complications. However we know what is needed to save women's lives. The reason that women are still dying is because women's lives are not valued, because their

voices are not listened to, and because they are discriminated against and excluded in their communities and by healthcare systems that fail to prioritise their needs. Human rights organisations such as Amnesty International, which has just launched a global campaign to reduce maternal mortality, are calling on governments to acknowledge that these utterly preventable deaths reflect widespread indifference to women's suffering and pervasive disregard for their fundamental human rights.

#### • **Towards the Full Participation of Women in El Salvador**

Women continue to be severely under-represented in elected positions in El Salvador, despite the considerable contributions they have made to rebuild the country almost 20 years after the end of its 12-year civil war. At the same time, women in politics can provide an entry-point to greater consensus-building in El Salvador, which remains a highly polarised society.

With UNDEF support, the Association of Salvadoran Women Parliamentarians and ex-Parliamentarians, ASPARLEXSAL, is conducting a project to correct a gender imbalance whereby currently, women make up 53 per cent of the electorate, yet occupy only 14 of the 84 seats in the Legislative Assembly. With the recent victory of FMLN in general elections after 20 years of ARENA Government, and the presidential handover on 3<sup>rd</sup> June 2009, the country is undergoing yet another crucial and challenging transition on its journey to build and consolidate a functioning democracy.

#### • **Documentary debunks myth that alcohol makes men violent to women**

The film documentary produced by Northern Michigan University features compelling stories

from four survivors, and additional insights from professionals in domestic violence, substance abuse and policing. The survivors featured in "Alcohol and Men's Violence against Women" hope that other women will not accept alcohol as an excuse for violence, or the suggestion that stopping drinking may render abuse history, from now on. Even though all these factors reinforce the fact that alcohol may be a contributing factor, the root cause of abuse seems to be a man's need to control. The DVD includes the 30-minute documentary and 30 minutes of special features offering advice and information on learned behaviour, substance abuse therapy, success stories and responses from law enforcement and ER nurses. It has both English and Spanish language options.

#### • **Human Rights Abuses against Transgender People in Honduras**

The 45-page Human Rights Watch report "*Not Worth a Penny*" details abuses based on gender identity and expression, including rape, beatings, extortion, and arbitrary detentions by law enforcement officials. It also documents police inaction and recurrent failure to investigate violence against transgender people. At least 17 travestis (as many transgender people are called) have been killed in public places in Honduras since 2004. None of these killings have led to a prosecution or conviction.
